



BCHW Rendezvous Tack Sale 2026

Consignment Sale Fees and Membership Requirements

The Rendezvous Tack Consignment Sale (BCHW) charges a commission on sold items. The rate depends on the seller's BCHW membership status. If your items are sold, BCHW retains:

- 17% of the sales price from current BCHW members.
- 22% of the sales price from non-members:

To qualify for the BCHW member rate, your membership must be fully paid and current before April 1, 2026.

Merchandise Tagging Requirements

Upon submission of the completed consignment agreement form (pg. 3), each consignor will be assigned a unique consignment number. This number will be used exclusively on the tags for all items submitted by the consignor and will serve as the sole identifier for those items. For privacy and consistency, consignors' names are not permitted on price tags.

- Items must be **tagged, priced, and clean**.
- **TAGS: should be attached by string or wire and tied securely** to keep them in place.
 - All **CLOTHING MUST BE ON HANGERS** and tags must be **attached to the clothing itself**, not the hanger.
- **Exception: SADDLES:**
 - **MUST COME WITH A SADDLE STAND** with your name on it. If you are open to offers, designate that on your tag and/or consignment form and a tack sale volunteer will facilitate the negotiation. Please **DO NOT** put your contact information on your tag.
- Items **must be in totes (preferred) or bags**.
 - **Western & English in separate totes**
 - **EACH TOTE/BAG LABELED with:**
 - **LAST NAME**
 - **CONSIGNOR NUMBER**
 - This will help ensure unsold items will be returned in your totes at end of sale.

Item DROP OFF, PICK UP, and Sale Notification

➤ Drop off times:

- **Thursday April 23, 9:00 am – 5:00 pm**
- **Friday April 24, 9:00 am - 5:00 pm**
- **Saturday April 25, 9:00 am – 12:00 pm**

➤ Pick up times for unsold items on Sunday, April 26:

- **8:30 am – 10:00 am** (break for Church services & awards)
 - **12:15 pm – 2:00 pm**
 - Items not collected by 2 pm will be donated to a nonprofit organization selected by BCHW.
- The BCHW Coordinator will notify consignors of their sales by **May 1**.
- Payments for sold items will be issued by BCHW via check and mailed within twenty days of the sale's end.
