Your volunteer mileage is also deductible. Make copies of your volunteer hours logs with mileage for your taxes. ↶

# BCHW Volunteer Hours

The BCHW volunteer hours Summary Report covers the reporting period from October 1, 2024, through September 30, 2025. These are the year-end totals, and they represent a job well done by chapter members, officers, and your Volunteer Hours Coordinator. The Excel document represents the totals by Chapter and by Agency.

**2025 BCHW VOLUNTEER HOURS = 55,683**  
(2024 - 55,502)

**2025 TOTAL VALUE = \$2,568,507.41**  
(2024 - \$2,476,837.56)

The overall hours have increased slightly from the previous year's totals. All the BCHW Volunteers put in a great effort, accumulating over 55k of volunteer hours. This is a time to give the entire BCHW-Volunteers a big thanks and hats off to everyone.

This needs to be said every year: the success of the BCHW Volunteer Hours program is due to the assistance of your BCHW VH Regional Committee. I couldn't get the volunteer hours reviewed and accurate without their help. Big thanks go out to Louise Caywood-PCC, JoAnn Yost-GHC & Kathy Iddins-SKT, who worked diligently to review and ensure accuracy in their chapters'

quarterly and final reports. We welcome Peggy Swanberg back to the 2026 BCHW VH Regional Committee.

Throughout the year, we continued to collect and report the BCHW Volunteer Hours on a quarterly basis to assist with chapters that struggle to complete the reports accurately. Quarterly reporting is also beneficial for chapters to keep up with VH data entry and make it easier to meet the final-year-end reporting deadline.

The BCHW Summary Report will also be provided to your chapter VHC for your chapter records. If you have any questions regarding the volunteer hours report, please contact me.

### BCHW AWARDS CATEGORIES

**LIFETIME ACHIEVEMENT** This award is for the BCHW member or couple who has shown a lifetime of dedication to BCHW by actively pursuing and promoting the organization and the BCHW Mission Statement in a variety of ways. This award is for recognition, not a contest.

Lifetime = 1, max 2 awarded

**LOPPER AWARD** This award is for a BCHW member who has demonstrated outstanding commitment and dedication to their chapter or to BCHW by participation and promotion of what the BCHW Mission Statement stands for. This is kind of an “all around” award, with the nominee being active in several different aspects of the many things that make up BCHW.

Lopper = 3, max 4 awarded

**CAMP COOK** This award is for the BCHW member who willingly keeps the campfires burning and the kettles hot and full of delicious food to share with others. Whether it is at meetings, work parties or social functions, they are in the kitchen making sure all are well fed.

Camp Cook = 1 awarded

Trail Warrior = 3, max 4 awarded

**DESK JOCKEY** This person is one of the behind-the-scenes people, always at a computer or running from meeting to meeting. They keep the wheels of our organization turning.

**JUNIOR BCHW** Our future! Who stands out in your chapter?

This person would participate in chapter events such as work parties, fund raisers, LNT/education, training or BCHW promotion such as parades.

**BACKBONE** This award is to recognize that special member who is always there when needed, ready and willing to do some special job that no one else can or will do, sometimes at the last minute. President's Diamond Award = 1, max 2 awarded

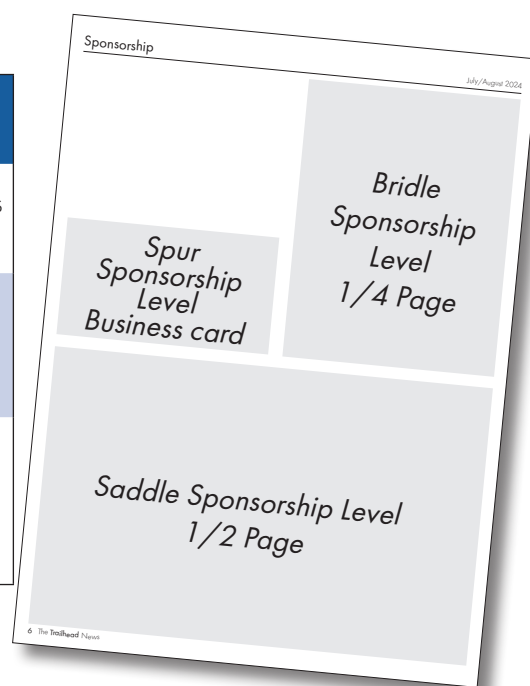

**P**roject Description: Pack forest (4300 acres) has been the focus of many equestrians since the Nisqually Mashell State Park has been under construction. Equestrians and like-minded groups have taken on the labor and some of the materials to build additional trails and clear 8 miles of trail loops in the first quarter of 2025. The parking lot was very small, and BCHW members brought in equipment to level and open additional parking areas. The expanded areas are 140' x 101' and a strip parallel to the road, being 140' x 21'.

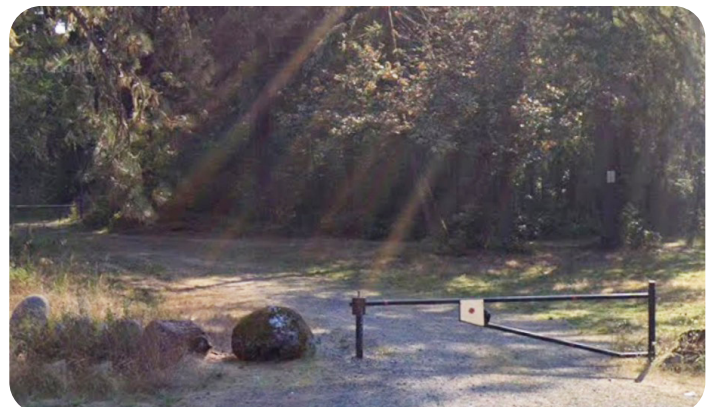
This request is to provide gravel and base materials to support the additional parking space that has been expanded. This is a joint effort between multiple groups.

**Funding Need Estimate:** The estimated need is 205 tons of gravel. Price estimate for delivered gravel to be hauled in is \$620 +/- per transfer truck load of 22 yards. This estimate is based on a value of 1.3 tons per yard, which equals approximately 8 combo loads to be delivered. Members with equipment will provide the labor to spread the parking lots and layer it 3"-4" thick. This request is for \$5,000.00 to be spent on gravel and hauling, which will begin the parking lot's layering.

**Partners (if any):** The labor came from chapter members of the Nisqually BCHW chapter, the Pierce County BCHW and WCMO.

Below are pictures of the project starting in March and April of 2025 - before the grant was applied for to provide the gravel.

Work to start the expansion was donated by Pierce County Chapter members prior to the application being submitted.

Thank you to BCHW for approving the 5K\$ grant application for the gravel to finish this work.

The Nisqually Chapter was awarded a grant in May to purchase the gravel, and members of both chapters have donated time and equipment to spread and compact it.

Recognition and a Big thank you to Diane McCuin for spurring us on this endeavor. Diane hosted a large work party with WCMO and BCHW members on April 6th, 2025, to add a loop through the existing trail system. This is what began the need for more parking in the area for horse trailers.

PCCBCH members Sam Nohra and Rob Humes coordinated with the forest managers to begin the expansion. Sam provided the equipment, and sidekick Dillon and others labored to clear, level and expand the area. Sam also has graciously made and provided a knee pad at the gate – for us OL FOLKS so we do not have to kneel in the gravel to open the lock.

Thank you to Amy Prummer and Kelly Parsons for finding Tellier Stump Grinding, getting bids, and working with Pierce County members to approve funding to have stumps ground out and removed in April of 2025.

Thank you to David Boe for providing equipment and coordinating with Pack Forest to meet for the delivery of the materials and for securing a compactor donated by Jim Sharbono. David did the spreading and compacting.

Thank you to Lynch Creek Quarry in Eatonville and Randles Sand and Gravel for the generous price reduction to keep the total within budget for the area with 5/8 minus gravel.

Jim Sharbono donated a very large commercial road compactor that needed to be transported via a lowboy and semi-truck, which was donated by Jerry Flowers, to move the equipment and complete the work.

A really big thank you to Jerome from the University of Washington for obtaining the approvals for the work and for being readily available to let us use this area.

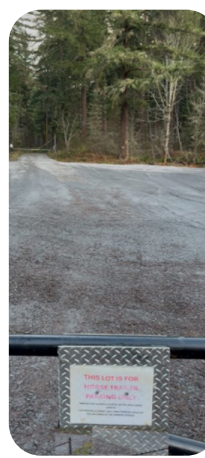

When BCHA was first proposed – in the Flathead Valley, back in 1973 - one of the stated intentions was to assist land managers with trail maintenance. At the time, it was always assumed that meant BCH volunteers would go out and work on trails, and for many years that was the case. As we entered the new millennium, we in BCHW began to receive out-of-pocket reimbursements from grant funds for volunteering on trails through our chapters.

In the early 2000s, several chapters continued to maintain trails, with or without grant funding. We also had several very successful statewide work parties, and a few teams not affiliated with chapters did some serious trail work as well. We migrated to a contract to handle the paperwork, and Jen Bond continues to do so and coordinate trail work on the Olympic Peninsula.

A few years ago, through Trail Operations Manager Tim Van Beek's efforts, BCHW was able to use grant funding to hire youth crews, who cleared many miles of trail for stock use! As we succeeded in securing additional grant funds, we earmarked more funds to pay for paid crews. As many BCHW members have observed, those young people can work closer to the ground than our aging membership! We continue to con-

tract with trail crews through their parent organizations for trail work, and we are determined to manage those resources so that the money is well spent.

Largely based on the experience of Barb Talbot, Diane McQuin, and the rest of the Black Pine team, we have developed a model that uses "Field Coordinators" to provide oversight and direction to crew leaders and their crews, and to coordinate pack support when appropriate. These Field Coordinators may receive reimbursement for travel expenses and, when sufficient grant funds are available, small stipends. Again, Tim Van Beek's coordination makes all this happen.

Our Trail Operations Team is helping the Grant Committee to evaluate where we can get the "best bang for the buck" while first supporting chapter and other volunteer team efforts, even in the face of declining volunteerism, an aging membership, and fewer qualified packers. Personally, I hope we never lose our personal involvement in trail work, even as more trail miles are opened by contracted work crews. BCHW is a volunteer organization, but the reality is that we can accomplish a lot more by spending grant money to support volunteers AND by contracting with work crews, Field Coordinators, and our Field Operations Manager and Grant Administrator. 



## Grays Harbor Chapter Grant Update

**T**he Grays Harbor Chapter wishes to thank the BCHW Chapter Grant Program committee for awarding us a \$1500 grant in 2025. It was put to good use.

Since 2018, thanks to our affiliation with BCHW, our chapter has leased 4700 acres of timberland from Green Diamond Resources. Located in the north Grays Harbor County area, just west of the town of Matlock and south of the Olympic National Forest. This area is referred to as the Schafer Grade.

Under this lease, which covers a non-motorized area, we have been allowed to put in approximately 35 miles of trails and signage, use the property for our annual Fund Ride without any additional charge, and camp overnight whenever we wish. Chapter members can buy keys to the three access gates and bring friends and family, as long as a BCHW Liability Release is signed and in their possession. This area is also open to non-motorized users free of charge, with no permits required. They are not allowed inside the gates except during hunting season. There is ample parking for trailers outside the main gate, with a good, safe ride around. We call this the Nokey Trail.

Our overflow parking and camping area inside the gates has been limited because the most popular area, an easy-to-access gravel pit, had previously been used as a shooting range. There was broken glass everywhere. Even though we picked up all the big pieces, the smaller pieces remained. Luckily, the tie-up areas for the horses were not affected, only the area where we parked rigs and rode to get from one end to the other. We were limited in safe spots to park and camp. Thanks to the grant, we were able to purchase and have delivered two large dump truck and trailer loads of gravel. Member Gary Falk brought out his tractor, and with our Schafer Grade chair, Beth Branshaw spotting for him, they got all the glass covered. Parking and camping for the summer of 2026 just got better! 🍀
