At the last meeting we voted to go ahead with the Davis/Microsoft funds and hire WCC (Washington Conservation Corp) to bring a group of 6 to work on thread on the Williams Lake trail for 8 days. We'll need

to have it logged out before they arrive. This project will be used as matching funds for a grant that MVBCH member Michael Liu is monitoring for Jason Ridlon—probably up Andrews creek with NW Youth Corp. Dates have not been decided yet and other trails might be worked on.

Four of us attended the most recent Methow Collaborative meeting. Lots of exciting things happening there. The Collaborative has a trail manager job that we can hopefully tap into! Information sharing is certainly the biggest need for all of us.

The Spring ride is going ahead! We're applying for permits and most jobs have a leader (except 'facilities'). We need a tractor and dumper to clean manure bunkers on Sunday.

Calendar events are being gathered if anyone wants to host a ride or work party on their favorite trail. Please let us know ASAP! We will have our Spring Ride on the BCHW website.

#### MVBCH JANUARY 13, 2022 MEETING MINUTES

Members present: Michelle Schmidtke, DK Williams, Ashley Ahearn, Mark Brantner, Mary McHugh, Cathy Upper, Bennet Upper, Kay McCready, Betty Wagoner, Michael Liu

The meeting was called to order by Cathy Upper, President

There were no corrections to the minutes of the 12/4/21 meeting

#### <u>Director's Report (DK Williams)</u>:

DK presented the highlights from the 4th quarter Director's board meeting:

- BCHW Nomination Report: Dana Chambers, president, Bob Iddins, vice-president, Kathy Young, Director, Tom Conner, BCHA alternate director, Secretary position is open, special projects is open
- Treasurer's Report: Teri will continue as treasurer until centralized accounting is up and running.
- Reimagine Committee: It has been decided to follow the BCHA model and form an Executive committee. The current directors' positions will remain in place.
- Need volunteers for Rendezvous.
- Website Changes: Launching an events calendar, submit to Kathy Iddins.

Cathy reported that the new Trailhead News is online and it describes the details of the director's meeting. She said Christina Cline (farrier and member) is our representative to Rendezvous and will give a talk about hoof health. MVBCH has donated \$390.00 towards a chain saw for Rendezvous.

#### Treasurer's Report (Bennet):

MVBCH has budgeted for Rendezvous attendance plus a donation. Donations to MVBCH in the past 3 months have been made and allocated towards trail work. The current total balance was provided to the membership at the meeting and chapter members may contact Treasurer Bennet Upper for current balances if interested. Mike Liu stated that we have additional funds from a state grant but it requires a 2.5 matching grant which should be no problem. Bennet emphasizes that all expenditures will go through him and the easiest way to purchase anything is with our credit card. Bill Ford and President Cathy will each have a credit card. Our budget has been submitted to the state.

#### New Membership Chair:

Megan Casey has volunteered to be our new membership chair.

#### Volunteer Hours (Kay MacCready):

Kay has nothing to report on Volunteer Hours.

#### Spring Ride:

- \* Cathy suggested we raise the price of the event to \$30.00 and the price of breakfast to \$10. A vote of members present resulted in unanimous approval of holding the Spring Ride. Cathy will apply for the permit and will start advertising. She said MVBCH needs to create some publicity flyers. She is soliciting help setting up a facebook page and she needs help with advertising. DK suggested that Cathy contact Megan Casey to help with the facebook page and advertising.
- \* There was discussion about whether to have the Dutch Oven potluck or just a regular potluck on Friday night. Betty suggested recruiting Willy Kemper for overseeing the Dutch Oven potluck.
- \* Rick and Shelly Jones are taking charge of the auction committee
- \* A facilities chairperson is still needed. MVBCH needs a tractor, san-i-cans, firewood, etc
- \* Cathy suggested a mid-ride break that offered coffee, cookies, granola bars
- \* Michelle is in charge of logo wear. She said there are lots of items available from previous years but may need to order more large and extra-large sizes of the current inventory
  - Betty is in charge of music and the route planning.

#### MVBCH JANUARY 13, 2022 MEETING MINUTES (CONT.)

Bennet said the 'bank' will have a card reader for processing purchases.

#### Trail Work:

- \* Landon, Rosemary and Mike Liu discussed trail projects for the 2022 season. There is a position open for a trail coordinator at \$40K.
- Cathy contacted Joe Hall because he has 4 weeks to work on the Wolf Creek and Cedar Creek trails.
- \* MVBCH can hire a WCC crew of up to six individuals to work on the Williams Lk trail and/or improvements at the Twisp River Horse Camp.
- \* Mike Liu said Jason Ridlon is trying to coordinate trail work with more regional groups rather than the individual chapters.
- \* The Pacific Northwest Conservation Corp is available to work on the Andrews Creek trail that accessed the Pacific Northwest Trail.
- \* The water system for the North Summit Horse Camp is probably going to be paid for by a USFS grant.
- \* Betty is in charge of putting together the 2022 ride calendar so she needs input from members.
- \* Cathy is coordinating with the Evergreen Bike Alliance to work on the Twisp River Trail and she needs input from members. She said the Virginia Ridge Trail project is still moving forward. Cathy said the planning phase grant for the Loup trails is still proceeding.

Cathy urged all members to fill out the WDFW survey about usage of the Methow Wildlife areas. Go to <a href="https://publicinput.com/R2352">https://publicinput.com/R2352</a> [please copy and paste the link if you cannot just 'click' on it] for the survey. Michelle said it's really important to urge better access via parking lots large enough for trucks and trailers.

Mary McHugh said the project to re-locate the South Pass trail has been stalled due to lack of change of ownership from the current owner's name to Jack Crammer's name.

  - Have possible candidates come to the January meeting.
  - Get a list of projects from MVTC members so they can be prioritized

- · Heide will talk to Brandon about presenting it at the next bi-monthly meeting
- Heide will talk about her new position as the Recreation Planner for WDFW at the January bi-monthly meeting
