Rendezvous is fast approaching and its time to clean out those tack rooms, that dark cubby in the horse trailer and all the forgotten corners of your barn! Legislative Report by Mark Vorce

HB 1838 Protecting, restoring, and maintaining habitat for salmon recovery. – short summary of bill: Requires, with certain specified exemptions, public and private landowners who own property adjacent to a body of water identified and mapped on a riparian management zone map to establish, maintain, and protect the riparian management zone.

STATUS: after a huge 2-part public hearing on January 19th & 21st this bill remains in the same committee. This bill is expected to go no further this session but is always good to keep an eye on this one through to the end. This bill would have HUGE effect on farmers, ranchers or anyone with water near or on their property. The state would compensate for their loss of revenue. But as usual, the compensation would not be remotely close to what the actual loss of revenue or usuage

<u>SB 5882 Clarifying the existence of riparian stock watering Rights</u> – short summary of bill: Establishes that nothing contained in the (department of Ecology) Water Code shall be construed to lessen, enlarge, or modify the existing rights of any riparian stock watering rights.

STATUS: This on the schedule for executive session in the Senate Ag Committee 2/3 @ 1:30pm.

HB 1928 Concerning equine industry support – short summary of bill: Creates the Washington Equine Industry Reinvestment Account (Reinvestment Account) in the State Treasury, funded through an annual mandatory State General Fund transfer. • Establishes the formula for calculating the amount of the annual transfer from the State General Fund to the Reinvestment Account. • Directs the Legislature to annually appropriate monies in the Reinvestment Account for a variety of purposes, including Washington Horse Racing Commission operations, breeder awards, nonprofit races, equine activities, race purses, equine health and safety programs, and maintaining and repairing facilities.

STATUS: After a public hearing in House Appropriations this bill is scheduled for executive session 2/3 @1:30pm.

SB 5504 Extending current discover pass free days from state parks to all state recreation sites and lands—short summary of bill: Requires the State Parks and Recreation Commission, in consultation with the departments of Fish and Wildlife and Natural Resources, to designate up to 12 days per calendar year where entry to a recreation site or lands is free. STATUS: this appears to be moving through channels for passage

SB 5865 Establishing recreational target shooting areas on public lands—short summary of bill: Includes recreational target shooting in designated areas in the list of activities where public and private landowners shall not be liable for unintentional injuries. • Exempts amounts the Department of Natural Resources receives from lease agreements to operate recreational target shooting facilities from the definition of fees for purposes of recreational immunity.

STATUS: It had a public hearing in the Senate Committee on Ag January 27th and remains there. Prognosis is that there is

conflicting policy language that needs to be fixed. Probably not enough time to do it this session. It will most likely be back next year.

SB 5608 Concerning free public access to state parks and lands – short summary of bill: Repeals the Discover Pass

Program.

STATUS: Probably not going anywhere this year. It remains in the Senate Committee on Ag since January 13th.

<u>Domestic Animal Waste (DOH)</u> – this is tabled until at least April. They will have more public comment periods.

Howdy folks, my oh my has it been a rough couple years for all of us. Hopefully we get can get back to some sense of normalcy. I am not much for words but I will throw in my 2 cents. Due to the Covid we have not done hardly any meetings, rides or work parties. This year I hope to change that. I really miss getting together with the members and going for rides. If you have any culinary skills, I really want to have you as a member. This is my first rodeo being the chapter president, so please be patient with me. From the Director's Chair

As I am sure a lot of you may have heard BCHW has been going through some changes. A big one that was implemented this last fall is the adoption of the Centralized Accounting Program. What it means in simple terms is all the funds across the state are now held in one account at the state level with sub accounts for each chapter. Every chapter has access to all of its funds without the headaches of having to maintain separate bank accounts. It has made the Chapter Treasurers jobs so much simpler by eliminating a ton of paperwork, making how we manage funds for memberships and chapter expenses so much easier. As with most things, it is a work in progress with everyone sharing thoughts and ideas, and I believe it will turn into a great system that will benefit all the chapters and make the state treasurers job better. Also at the December meeting the BCHW Board of Directors approved the formation of an Executive Committee to handle the day to day business of BCHW. Typically business that couldn't be handled by the President or Treasurer had to wait until one of the quarterly Board of Directors meetings but that will change. The President is the head of the Ex. Committee and the Board of Directors still has the final say and gives direction to the Ex. Comm. The Ex. Comm. will be made up of the President, Treasurer, Secretary, three chapter directors and three non-directors. An Implementation comm. has been formed to rewrite the BCHW By-Laws to make this all legal. This should be accomplished by June and the final vote to approve should happen at the June BOD meeting.

Something new we will be trying out for the chapter is changing how we hold our meetings. It was proposed and approved we have a business meeting once a quarter online via zoom. Other chapters have been doing this quite successfully since the start of the pandemic and more members have actually been able to attend meetings as they are right in the comforts of their own homes! What a world we live in now. The proposal also suggested we have one to three social gatherings per quarter in addition to any scheduled chapter rides or work parties. The plan is to have some speakers come in and discuss various pertinent topics, have presentations from folks such as a shoer, vet, some of our own packing experts, who ever you want to hear from. How about another packing clinic with Robert Eversole, The Trailmeister? Maybe a session on how to make a simple mohair cinch or breast collar, leather working, massage therapy for your horse - the possibilities are endless. What would you like to learn about or skill do you have to share? Our meetings don't all have to be boring dry business meetings, let's throw some social time in the mix and see what we can get going. If anyone wants help getting Zoom set up on their tablet or computer I am happy to help and I think Mark is our expert on using Zoom with your phone. Reach out to either of us please before the upcoming meeting on Monday February 7 at 7pm and we will help you get set up. If anyone else has good Zoom skills they'd like to share, give a shout! We can make this successful and I really believe it will open some new doors for us in how we communicate.

2021 Packing Support Report by Len Rolph

Our Chapter completed 3 projects this summer with good weather on all three. The only fly in the ointment was yellow-jacket and hornet nests very close to the trail on the two Foggy Flat runs out of the Muddy Meadows trailhead. We got hit twice, going both directions, but sprayed the ones we located. A little excitement, but the only damage was to my left ear, which was still sore on Wednesday after Sunday's trip. No reports from the horses and mule on their sore spots!

The main project this year was packing supplies both in and out for a new (in this area) volunteer group called Wilderness Volunteers. It's a nation wide organization, and joins the Pacific Crest Trail Assoc. and the Washington Trails Assoc. doing trail work in our area. They contacted Dean Robertson, at the Forest Service, and Dean asked for our help.

This group wasn't familiar with pack animals, how to organize their gear or the necessity of evenly packed loads, so it took an extra hour or more to get loaded. We needed 6 pack animals but managed to get everything on 5. Hopefully they will be better prepared next year.

The third trip was the Indian Heaven Fish Plant. We delivered 1,000 cutthroat trout fingerlings to Bear and Deer Lakes. We had perfect weather, no bees, no mosquitos and as far as we could see, a total mortality of only four baby fish, two at each lake.

Thanks to everyone who helped with the packing. We all enjoyed the trips, and the trail crew, the Forest Service and the Washington State Department of Fish & Wildlife, Goldendale Hatchery, all expressed their appreciation several times. We get a lot of good word of mouth support for pack animals in the back country with this work.

Our packers this year were Craig Vance, Mark Vorce, Cyndra McLoud, Ray Gamble, Travis Miller and Len Rolph. We appreciate our packers and the commitment they make to help us accomplish our volunteer work. Lyris Woolridge and Marilyn Milestone helped with the fish plant. This was the first time for each of them to go along on one of our volunteer trips. They expressed appreciation and enjoyment of the day.

We were gearing up and recruiting packers for a 4th project this September of packing 35 timbers for a replacement bridge out of Mt Adams Horse Camp. Due to a steep downhill trail, with animals loaded with timbers, and a sharp turn or two, there were some questions and concerns. The Forest Service ended up not needing our help because they could use a tracked trail machine that could haul 4 timbers per load safely. They are aware, though, that we are more than happy to help anytime. this bridge desperately needed replaced and it was made possible by a grant Mark Vorce worked up and applied for some time ago. Mark has obtained grants for several projects.

Overall it was a productive year we all enjoyed with no injuries, great weather and the knowledge we helped to keep the trails open and safe for everyone.

Mt Adams Chapter Meeting Minutes for Sept 19, 2021

Vice-president Len Rolph called the meeting to order at the Glenwood Grange Hall in Jim Pence's absence. There were twelve people present.

Mark Vorce introduced our special guest, State Treasurer Teri Starke. She explained she was present to explain the new Centralized Accounting System, the reasons for it, to correct misinformation and answer questions and concerns. Teri gave a wealth of information and several handouts. There was quite a bit of discussion and many questions answered. We really appreciate Teri taking a whole day to come from Ellensburg to talk with us. Mark made a motion for our chapter to start the process for centralized accounting. Terri Crawford seconded the motion; unanimous vote in favor. Credit cards for our account will be held by Terri Crawford, Mark Vorce and Connie Baugher.

Directors Report: Mark explained the vacant state officer positions; that BCHW is going to be "reimagined with regionalizing". There was discussion.

New Business: Linda Turner reported that there had evident been substantial knapweed at Mt Adams Horse Camp. We need to have more interesting meetings. This discussion included possible presentations of general interest t the meeting, food and ways to create camaraderie, more rides.

Terri Crawford reported riding with friends at Brooks Park. She cleaned a trail herself while someone was there to hold her her horse, Terri explained the hierarchy of authority over the park and that it was really appreciated when she cleared an entire trail. She just did it. Maybe our bunch could?

Terri will compile a newsletter again agin, folks, but she wants information to put in it. Someone want to write an article of helpful information? Ads for "sale" or "want' of horse or stock related items; other ideas to make an interesting newsletter.

After discussion, our next meeting will be on December 5 at 21:00 pm for our Christmas party. (Sadly our party was canceled due to lack of participation)
