DNR says 'free reservations'...with Discover Pass... There are some trail interruption's...as in logging going on...at least until July...but there are 'still 40 miles of trail open'. Closures mostly at the western boundary.

Follow the link <u>saharacreekcampreservations@gmail.com</u> for securing reservations...I plan on doing so directly. I talked to a 'Mr Simmons' of DNR recreation. **360-825-1631**. Skip all the 'canned info'...**go to O for operator**...ask for the Rec person for Shara HC...shud be Mister Simmons.

Reservations are available with a minimum of 3 DAYS and a maximum of 3 MONTHS notice. Requests outside of those parameters will not be considered. Reservations are not available over state holiday weekends. All campsites will be open the Thursday before until the Monday after a holiday on a first-come, first-served basis. All motor vehicles and trailers must have valid DOL registration. Each licensed motor vehicle must display a Discover Pass to camp in Sahara Creek Campground (towed trailers do not require a Discover Pass to be displayed). Sites 1-20 are equestrian camping only. Sites 21-30 are open to all non-ORV campers (equestrian campers included). Site 28 is a designated ADA campsite which requires a differently-abled DOL placard to camp in.





### **Cyrus Horse Camp**

May 17th—20th

#### **Directions:**

#### From Hwy 97:

- Exit Norris Lane and go east approximately 2.5 miles.
- Turn right on Springer Rd (Forest Service Road 5740).
- Turn left onto Hagman Rd (Forest Service Road 5750) and proceed approximately 1 mile.
- Cyrus Horse Camp will be on the right.

#### From Hwy 26:

- Exit and head west on Laurel Lane (Forest Service Road 96) for approximately 2 miles.
- Turn left on Forest Service Road 5750 (just before the cemetery) and proceed for approximately ½ mile.
- Turn right to stay on Forest Service Road 5750 at the junction with Hagman Road (Forest Service Road 5750/5760) and proceed for approximately 1.5 miles.
- Cyrus Horse Camp will be on the left.

The trails/roads can be rocky so shoes recommended. Dog friendly camping There is a variety of elevation trails and the opportunity to do some cross country riding. There will be gates that need to be opened and closed due to cows so make sure you go with someone who can get on and off their horse when needed.

Email Barb Thomas at pineywoman1@aol.com if you are coming. While we can't guarantee that we can fit everyone in without dispersed camping it would help knowing to look out for folks.

Cyrus is located on Hwy 26 11.1 miles out of Madras headed towards Prineville. Look for a sign on the left of the hwy. that points to a right hand turn to Haystack reservoir. Go about 2 miles and make a left turn on FS road 5750. You will go across a cattle guard. Turn right at the next intersection and follow that road to the camp on the left.

### Escure Ranch from 25th to 29th of May, the Memorial Day weekend.

The equestrian camp was built through a partnership of BLM with the BCH, Ponderosa Chapter. The Escure Ranch is 12,000 acres open range, located roughly 25 miles south of I-90 at Sprague (Exit 245). Formerly a sheep ranch run by Basque sheepherders, the ranch contains a stretch of Rock Creek, including Towell Falls as riding destinations. Some trails follow an old ranch road with views of the valley, basalt outcroppings, aspen, spring wildflowers, and native bunchgrass.

**What you will find:** concrete outhouse, equestrian water (no potable water), 10 corrals, highlines for 7 horses and a manure bunker. There is a wide open, large, flat area to camp, fire rings (bring wood). Since there are no trees bring your e-fence.

This is first come first serve, no reservations and on the long weekend it can be a bit more busy than usual. Ken Carmichael, BCH Ponderosa Chapter and BCHW committee chair most likely will be there that weekend also.

**Directions:** On state route 395 from Tri-Cities going North to Spokane, take exit 245, Sprague. Go south on WA-23 for 12.5 miles. Turn right onto Davis Road for another 7.0 miles, then turn left onto Jordan Knott Road. After 2.2 miles, on Jordan Knott, you'll arrive at a fork, stay right to stay on Jordan Knott for another 2.5 miles to arrive at the parking area.

# (LNT.org): A Guide to Minimum Impact Camping and Stock Use Techniques

# Reminder Seven Principles of LNT:

Plan Ahead & Prepare. Travel & Camp on Durable Surfaces.

Dispose of Waste Properly. Leave What You Find. Minimize Campfire Impacts.

Respect Wildlife. Be Considerate of Others.

Go to LNT.org and pledge to pickup 30 pieces of trash in April on your next visit to the great outdoors. You may win a prize. Every year the world generates 2.1 billion tons of trash.

# Get Ready for Camping with Your Horse in 2023:

LNT is a federal program to teach us how to preserve nature for generations to come. After the pandemic, attendance to parks grew by 75%. More attendance means more trash and damage and increases the importance of LNT concepts. NIKE sponsors LNT as well as other big corporations. The philosophy begins with awareness, attitude and a set of guidelines. The following website has an informative 2 page brochure for us equestrians by BCHOregon: http://www.bcho.org/wp-content/ uploads/2013/06/Leave-No-Tracefor-Horsemen-3fold8-14.pdf

A. The first page has a list of questions for you to answer to evaluate your stance on LNT.

B. The second page goes into more detail about the 7 principles.



**1. Plan ahead and prepare:** Use checklists, research the spot by asking others, plan plan plan...

2. Travel and camp on durable surfaces: Stay on trail, if you can't then spread out so ground can recover easier, try to keep camp as small as possible, microorganisms live in soft soils

- **3. Dispose of waste properly:** Pack out what you pack in; dig cat holes for human waste 8"deep
- **4. Leave what you find**: Avoid damaging live trees and plants. Don't hammer nails into trees or carve into them. Leave natural and cultural artifacts for the next person to enjoy.
- **5. Minimize campfire impact:** You can replace the need of cooking on a fire with a camp stove. If you do need to make a fire, please use designated fire rings.
- **6. Respect Wildlife:** Try not to disturb animals and birds. No feeding either that might upset their digestive system or get them used to humans. Bears can forage around your tent so

learn how to store food properly.

7. Be considerate of others: We are stewards for equestrians everywhere and the way we treat the public can reflect on all of us, try to be polite and put yourself in their shoes.

8. Minimize Horse Impact:

Make highlines tree/ environmentally friendly, sprinkle pine needles on used area when leaving. Learn good trail etiquette by staying on trail and explaining to hikers where to stand so as to not spook your horse. Be careful not to overgraze pastures. If watering, relax horse away so he does not pollute water with feces. A hiker passing by might want to drink from that stream. There really are lots of ways to practice LNT. Don't forget at home also, we have to clean up there too. Do your best wherever you are, it is up to us
